This **STUDENT LOAN TRANSFER AGREEMENT** (hereinafter the "Agreement") is made on the day of 2016 between **TAITA TAVETA COUNTY EDUCATION FUND BOARD**, a body corporate established under the Taita-Taveta County Education Fund Board Act having its head office in Taita-Taveta County of Post Office Box 1066-80304 Wundanyi, Kenya (hereinafter "TCEFB") which expression shall where the context so admits include its successors and assigns of the one part; the **LOANEE** and the **HIGHER EDUCATION LOANS BOARD** a State Corporation established by the Higher Education Loans Act, Cap 213A of the Laws of Kenya and having its offices in Nairobi, Kenya of Post Office Box Number 69489-00400 Nairobi, in the said Republic of Kenya (hereinafter "HELB") which expression shall where the context so admits include its successors and assigns) of the other part.

WHEREAS:

- A. The goal of Taita Taveta County is to improve access to higher education by offering financial support to identified students from the County studying in identified institutions of Post-Secondary Education in Kenya and HELB is duly mandated to grant loans, bursaries and scholarships to Kenyans to assist them in obtaining higher education at recognized institutions within and outside Kenya has agreed to offer financial support in the form of loans (hereinafter collectively referred to as "**the Parties**") agree to co-operatively work together to assist students in Taita Taveta County to access education.
- B. By this Agreement the Parties agree to define the scope and their commitment to the Project approvals and timelines for transfer already awarded student loans initially issued by TCEFB to HELB for loan recovery responsibility.

NOW, THEREFORE, in consideration of the mutual agreement herein set forth, the parties hereby agree as follows:-

- 1. Upon execution of this Agreement, the Student already awarded student loan TCEFB in accordance with the terms and conditions stated in this Agreement and on the terms of HELB's Standard Loan Application forms.
- 2. The Student will remit the already awarded student loan to HELB and only those Students who accept to transfer their loans to HELB are eligible for an award of student loan from HELB upon successful application.
