1. KENYA REGISTERED COMMUNITY HEALTH NURSES

Duties and responsibilities:

- 1) Assessing, planning, implementing nursing interventions and evaluating patient's /client's outcomes.
- 2) Providing appropriate health care services including Integrated Management of Childhood Illnesses (IMCI)
- 3) Immunization and reproductive health services.
- 4) Providing health education and counselling to patients/clients and community on identified health needs
- 5) Referring patients / clients appropriately
- 6) Facilitating patients' admission, initiating nursing process and discharge plans.
- 7) Maintain records on patients/clients health condition and care
- 8) Ensuring a tidy and safe working environment.
- 9) Keeping records of drugs, supplies and other commodities.
- 10) Guide, supervise and counsel staff providing routine health care duties.
- 11) Collecting, compiling and analyzing data for decision making for service delivery, planning and policy making.
- 12) Implementation of community strategy with other health service providers.

Requirements for Appointment:

- 1) Be a Kenyan citizen(ID/Passport is a must)
- 2) Have a Diploma in any of the following disciplines: Kenya Registered Community Health Nursing, Kenya Registered Nursing, Kenya Registered Midwifery, Kenya Registered Nursing/Midwifery or Kenya Registered Nursing/Mental Health and Psychiatry from a recognized institution;
- 3) Have a registration certificate issued by the Nursing Council of Kenya;
- 4) Have a valid practicing license from Nursing Council of Kenya
